Requirements

- **ONE** of the following:
 - o Bachelor's degree in a teaching content area OR;
 - o Bachelor's degree in any area **and** 32 semester hours of content area coursework from a regionally accredited institution
- Pass the applicable <u>licensure content test</u>
 - o You can register for the appropriate content area test at the Illinois Licensure Testing System (ILTS) website which can be accessed by visiting; <u>http://www.il.nesinc.com/</u>
- Submit ISBE form 83-88

The district must also maintain a weekly mentoring and coaching log, and submit the log annually to its ROE/ISBE, using <u>ISBE Form 83-82</u>

*83-82 forms should be sent, annually, to licensure@kaneroe.org by June 30th of the current fiscal year.

<u>Notes</u>

- While working on approval, the educator <u>must</u> complete:
 - o An approved educator preparation program
 - o edTPA
 - o Student teaching experience
 - 1 year of experience on the STA *plus* a proficient or higher evaluation rating will waive student teaching.
